Checklist for a German National Visa

- MEDICAL TREATMENT (more than 90 days) -

You are ill and have a medical certificate issued by the local physician concerning the urgency of the illness and that the treatment cannot be done in Rwanda. You organized an appointment in a German hospital.

Before booking an appointment, please prepare the following documentation for your visa. The following documents are to be submitted **personally** at the Embassy **after booking** an appointment.

IMPORTANT:

- 1. Please provide the <u>original documents</u> in the **first (1.) pile** in the below mentioned order!
- 2. Please also provide two copies of all documents in two (2) identical piles!
- 3. The Embassy reserves the right to request additional documents.

		Where applicable: <u>Declaration</u> fully completed and signed regarding contact details and power of attorney
		Valid passport (valid for at least 6 months and with at least two (2) completely empty pages)
		Recent biometric passport photos (see specimen photos, other photos cannot be accepted and delay the visa process)
		Original medical certificate issued by the local physician concerning the urgency of the illness and that the treatment cannot be done in Rwanda
		Written confirmation of an appointment in a German hospital or with a doctor stating estimated period of treatment
		Proof of accommodation in Germany
		Proof of settled payments of the estimated treatment costs (in form of a blocked

account possible)

	Proof of adequate financial means
	Original letter from employer which includes working position, start date of work and salary or original letter from school or university
	Original salary statements for the last 3 months,
	Original bank statements of the last 3 months, original and two (2) copies
	Social security fund (RSSB)) at least the last 3 months
	Proof of adequate health insurance cover: Health insurance in line with EU standards (covering the entire Schengen area, minimum coverage of 30,000 €, valid from the day of entry for the entire stay.
	In case of previous long term stays in Germany: deregistration conformation from the registration office of the last place of residence
	Processing fee of 75 €. Payable only in cash in RWF .
