Valid passport (valid for at least 6 months and with at least two (2) completely empty pages)
Recent <b>biometric passport photos</b> (see specimen photos, other photos cannot be accepted and delay the visa process)
<b>Invitation letter of spouse</b> indicating the address where the applicant will stay together with the spouse in Germany
Copy of the passport of the spouse
Official certificate of recognition as a refugee of the spouse who lives in Germany
<b>Timely notification</b> in accordance with Section 29 (2) no. 1 of the Residence Act, which offers your spouse and minor children a simplified procedure for family reunification in Germany
<b>Original legalized birth certificate</b> ("acte de naissance") (if it is a non-Rwandan certificate the authentication might have to be certified by the German Embassy of the respective country)
